- New York births/year: ~250,000
- New Jersey births/year: ~101,000
- Both states use Neometrics
- Both states have secondary site to receive samples

## Scenario

### •Laboratory can not perform testing: power outage, flood, fire damage, etc.





### **Wounded state:**

- -Adequate staff is available
- -Secondary site available to receive accession and ship samples

### Follow-up performed by wounded state
